APPLICATION FORM FOR STATIC ENGINE EXHIBITS

During the time spent at the Country Fair, Exhibitors **must** be covered by **Public Liability Insurance** of not less than £100,000 on any one accident.

Changes in law deem the **Event field** a **Public Highway** and as such any **self-propelled** machine must be covered by at least the **Road Traffic Act Insurance** if that machine is to be driven on the **Event field**.

Any Person wishing to drive any machine on the show site must hold a current **Driving Licence** for that machine.

Exhibitors must abide by the **Safety Code**; a copy is available on request.

Please note that the Show is open to the public from 11-00 AM to 5-00 PM and there should be no vehicle movement within the showground between these times.

The Showground will be divided according to stand types so that similar items are together. Please indicate the size and type of stand required. Stands for Static Engines will not be allocated prior to the event but will be allocated on the day on a first-come-first-served basis. The only way that vehicles can be guaranteed to be together is for them to arrive together.

Driving Licences and Insurance Documents must be available for inspection on the day.
